RESOLUTION NO. 20-45

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, WAIVING FEES FOR 2020 COMMERCIAL MOORAGE AND AIRPORT LEASE PAYMENTS FOR COMMERCIAL BUSINESSES CLAIMING ECONOMIC HARDSHIP RELATED TO THE COVID-19 PANDEMIC

WHEREAS, the Valdez City Council seeks to mitigate the long term economic impacts and financial hardship to commercial businesses resulting from the COVID 19 Pandemic; and

WHEREAS, a waiver or refund credit of 2020 commercial moorage fees and airport lease fees will provide long-term relief and stability to commercial business in Valdez; and

WHEREAS, the Mayor's Economic Recovery Task Force recommends waiver of moorage and airport fees for those commercial businesses which submit a claim for hardship due to the COVID 19 Pandemic.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VALDEZ, ALASKA, that Harbor commercial moorage fees and Airport business lease fees shall be waived effective January 1st, 2020, thru December 31st 2020 for commercial businesses claiming economic hardship.
